

Consent to processing of personal data of participants of Hackathon

«SafeSpeak-2024: Deepfakes Detection for Voice Security» (hereinafter - Contest)

I, acting freely, of my own free will and in my own interests, give the Autonomous non-profit organization «Institute of Artificial Intelligence» (address: Russian Federation, 121170, Moscow, Kutuzovsky Ave., 32 bld1, room. 4.v.08.) (hereinafter - Institute) consent to the processing of my personal data with or without the use of automation tools on the following terms (hereinafter - Consent).

1. Purposes of processing and composition of processed personal data:

1	Organization and conduct of the Contest, including providing an opportunity to participate in the Contest in accordance with the Rules of the Contest, sending notifications related to the Contest, eliminating errors in the operation of the Contest site. Information about the registration of a natural person in the tax office at his place of residence (if available), information from the identity document, bank details, information from documents for determining the tax status, Prize information, information from the agreement on distribution of prizes between the Team Members, other information requested by the Institute as part of the prize payment and which I can provide myself in any available way.
3.	Assistance in attending the award ceremony of winners of the Competition, organization of accommodation and transportation of winners to the territory of the award ceremony.	Address of residence, telephone number, e-mail address, information contained in the identity documents and other personal data that I can provide to the Institute or the contractor of the Institute by any means available.

2. Actions carried out with personal data: collection, recording, systematization, accumulation, storage, updating (update, change), extraction, use, transfer (provision, access), depersonalization, blocking, deletion, destruction of personal data.

3. Transfer of personal data

The Institute has the right to transfer personal data and to entrust their processing to the following persons:

Within the scope of objectives 1-3, the Institute is entitled to transfer personal data and entrust their processing of the Order of the Red Banner of Labour to the federal state budget educational institution of higher education «Moscow Technical University of Communication and Informatics» (Russian Federation, 111024, Moscow, Aviotromotornaya street, bld.8a).

3. **Processing time:** consent is valid from the moment of its provision until the purpose of processing personal data (performance of all duties of the Institute in accordance with the Rules of the Contest, holding the ceremony for awarding the winners of the Contest) or withdrawal of the Consent, whichever comes first.

I am informed of my right to revoke my Consent at any time by sending a notice to the e-mail address: safespeak@mtuci.ru, or the original such notice to the Institute by registered mail or courier service (address: Russian Federation, 121170, city of Moscow, Kutuzovsky Ave., 32 bld.1, room. 4.v.08.).

I am informed that this Agreement is written and given by me in the Russian and English languages. In case of differences, the Russian version has priority.

I am informed that withdrawal of the Consent may result in the inability to continue participating in the Contest, the award ceremony of the winners of the Contest or the inability of the Institute to perform any duties before the Contest participant according to the Rules of the Contest.

If any provision of the Agreement is declared invalid, the provisions of the other provisions shall not be void.
